NCCAA Chairperson: Shaun G.

This is a full time job. It is a pleasure to be your trusted servant. I signed the contracts for the Santa Rosa June 2016 Conference. The price is \$7,000. Times are changing and things are getting to be more expensive. If you need help with the negotiations contact me for help. We need to be more thorough. San Ramon, 3/31 through 4/2 2018, is Easter weekend. That venue is normally \$32,000. Marriott corporate hotels are cost competitive. Fairgrounds, Portuguese Halls and such are the direction we are heading for conference venues. We are out of the bidding for the Bay Area and Coastal areas. I attended the Foster City Host Committee meeting last week. They have a great group assembled. At our last Steering Committee we held the first Ad Hoc Inventory Meeting. I need everybody's help. Increase Conference Registration from \$10 to \$15 pre-registration and from \$15 to \$20 at door

A future bids:

Carole H.: Proposed a bid for Lodi at the Lodi Grape Festival Grounds. The dates are Oct 13, 14, 15 2017 so it won't be hot. Total bid is \$5,000. We think we can bring that cost down a bit more. We are excited to host another Conference.

Roger B.: Spring 2017 3/10, 11, 12, Foster City. We need to fill 150 rooms, Total bid is \$9,000. Venue is at Crown Plaza Hotel. In the past we've been required to fill 200 rooms. We have made room count before except once and the local committee came through. Prices are slowly going up. Increase in Registration fee is important to help us meet costs.

Please, when registering for the host hotel, do not use other discounts otherwise that room won't count toward our room count.

New Business:
