His passing was a severe blow to all of us here in the Salinas-Monterey-Watsonville area and a host of friends in and out of AA mourned his death. Since he was busily "Carrying The Message" at the time of his death, it is now up to all of us to see that his great work goes forward—as he would want it.

Communication Between General Service And AA-at-Large Can Be Greatly Improved

The following is a thought-provoking series of suggestions sent to GOOD NEWS by their author, Chuck G., General Service Delegate for Northeast Ohio, who presented them at the Sixteenth General Service Conference in New York City in April, 1966 — The Editor.

Across our land, one finds wide variations in the understanding of General Service by AA-at-large. In some areas, the Intergroup Office and allied groups exhibit a fairly thorough understanding of General Service and have developed a good working relationship. In other areas, there seems to be little understanding; very little mutual effort and almost no support.

Without going into any of the reasons for these differences, which are many and varied, the following are presented as suggestions which might be adapted by anyone wishing to develop or improve upon relationships between General Service and AA-at-large.

For example, consider the "Responsibility" theme set by the world-wide convention in Toronto in July, 1965. Certainly no AA can argue the need, if we are indeed **responsible**, for AA to communicate with doctors, social agencies, the courts and the clergy. Note that the word is "communicate"; not

promoting but indoctrinating and explaining.

This is a job which should be done locally, by the Intergroup office, club or other central AA organization.

Another area is that more direct and personal communication between General Service at the local level and AA-at-large.

In the same area of more direct communications, the local central AA organization and General Service could collaborate on a series of one-minute scripts which would explain the relationship of General Service to AA.

Any major area-wide meeting is an opportunity for mass communication. The organization and work of General Service should briefly explained.

Many areas have "training" or "beginners" meetings on an organized basis.

Some areas have local publications such as the Cleveland "Central Bulletin", the San Francisco area "Good News", etc.

The entire subject boils down to AA and **service**. Objectives are mutual — to help the alcoholic; "to practice these principles in ALL our affairs!"
