AGENDA TOPICS FOR 1976 CONFERENCE

The 1976 Conference theme is "Sponsorship, our privilege and responsibility". The following are some suggested questions and comments which G.S.R.'s are encouraged to discuss with their groups, where they feel it is appropriate, or to consider individually. Please bear in mind that these are just suggestions, are not meant to be limiting, and are simply an opening wedge for discussion and through at the Pre-Conference Assemblies for the Coastal and Interior Areas.

Sponsorship and 12 Step Work: 1. Does your group feel A.A. sponsorship is slipping? If so, why? 2. Is sponsorship as vital to A.A. members as it was in the early days? 3. What can a group do to encourage sponsorship? 4. Are we turning sponsorship (and 12 step work) over to the professionals? 5. Are members of your group willing to make 12 step calls? Are they registered with your local central office or teleservice committee as available? 6. On a personal basis: (although group might want to consider questions) What do you consider sponsorship? Do we offer counseling or friendship? Is 12 step work the same as sponsorship? Can the group take the place of an individual sponsor? What are the rewards of sponsorship, other than insuring sobriety, to the sponsor? If you have sponsored someone from an alcohol recovery program, hospital or institution, what has been your experience?

A.A. Literature: 1. Assuming it is financially feasible to publish the Big Book in paperback form, does your group approve or disapprove of doing so? Why? 2. G.S.O., as a service to members and with no profit to itself, arranged for limited distribution of the book "Bill W.", published by Harper and Rowe, and permitted its sale on the floor of the Denver Convention. Does your group have an opinion about this? Are there circumstances under which G.S.O. should distribute non-A.A. publications? If so, what are they?

Back To Basics: 1. Does your group feel that we are getting away from A.A. basics in the content of [Continued on page 3]

Konocti '76

Reservations by AA's and AlAnons are being accepted for the Fifth Annual Post-Conference Assembly of the Northern California's General Service. The Assembly will be held once again at Konocti Harbor Inn on Clear Lake on Saturday and Sunday, May 15th and 16th.

NCCAA Annual Spring Convention

Why not plan to attend and to share at the Spring Conference in Fresno on March 12 thru 14. Help elect a new Secretary for the Northern California Council of AA. P.I. Footnotes [California, Northern Coastal Area]

A facet of public information in Alcoholics Anonymous which is fast becoming of major importance is in effect a new form of "Twelfth Stepping", and is speaking by AA members at non-AA meetings. This type of speaking is completely a different form of presentation than is heard as an "AA pitch" at an AA meeting, and requires extra alertness and finesse on the part of the speaker. Non-AA groups usually are not interested in "drunkalogs", but want to know what AA is and what it is not. Familiarity on the speaker's part with the 12 Traditions is manadatory.

While frequent requests are made for AA speakers by non-AA service organizations, most requests are received from schools. The schools range all the way from elementary schools to colleges. Speakers also are needed for DWI classes and other sessions formulated by the courts and county departments—e.g., the probation department.

Requests for such speakers are channeled through local central offices and/or intergroups, and any AA member who feels he is available and qualified for such an assignment should contact his local secretary. Suggested qualifications iclude a minimum of two years continuous sobriety, and availability during daylight hours, because most requests (particularly schools) require speakers during day hours. Some intergroups have formed Speakers Bureaus to control and screen speakers, because experience has shown that some AA's who are not fully qualified, accept such speaking engagements on their own initiative and sometimes present a distorted view of AA to the public. Each county in the Northern Coastal Area of California has an elected Public Information Chairperson, and further information may be obtained from them.

The CNCA Public Information Committee has begun discussions which will lead to an area-wide symposium later in 1976 and to the publishing of Guidelines on Speaking at Non-AA Meetings. More in future columns...

many of our meetings? (a local G.S.R. said his group thought A.A. was going "beyond A.A.") 2. What are the "basics"? Are we talking about: Our own recovery from alcoholism, the Big Book, Twelve and Twelve? 3. Do we tell the newcomer exactly what A.A. is?—And is not? 4. Are there problems at meetings with: (a) talks on "alcoholism", rather than on recovery through the A.A. program? (b) use of non-A.A. literature? (c) discussion or use of other therapies (T.M., T.A.) etc.? 5. If there are problems, what can be done?

Public Information: 1. Is your group aware of A.A. public information activity in their community? 2. Do they feel it is inadequate, adequate, or excessive? 3. If members of your group are interested in P.I. service work, do they know how to go about it—who to contact, etc.? 4. Does the group have an opinion as to whether A.A. - P.I. is "explaining" or "selling" A.A.? (What is the P.I. message?) 5. Comments would be appreciated by those who have been involved in P.I. work: When speaking at non-A.A. gatherings, who are we talking to? What do they want to hear? Are drunkologues proper? What are problems of communication? What is the importance of knowledge of A.A. recovery program (steps; traditions; history; A.A. structure?) What are the "fringe benefits" to the member from P.I. work?

General Service Conference Delegate: 1. Does your group know what a delegate is? What a Conference is? 2. Does your group know how they can use their delegate (and G.S.R.) to make known their thought and feelings to G.S.O. and to the Conference? 3. We would like the thoughts of present and past G.S.R.'s and any interested A.A. members as to: (a) How the delegate can get his service message to the area; (b) Whether the delegate is carrying the area conscience to the Conference; (c) Conference actions and attitudes to the Area; (d) How can the D.C.M.'s and G.S.R.'s help the delegate in these efforts? Do you think that delegates and past delegates (and for that matter any of us involved in A.A. service) should mention this service responsibility when speaking at A.A. meetings? Any comments about what the delegate might do, or should not do, would be appreciated.

All comments are solicited. The Area Delegates particularly appreciate written responses. You may send them directly to your Area Delegate, give them to your D.C.M. or D.C.M. Chairperson, or mail them c/o GOOD NEWS.

REFLECTIONS

Consider this

We are the talking tribes. The tongue is one of the most mobile structures of the human body, and to fetter its symbolic gestures is to dry up the deep springs of our human-ness. To restrict the free and independent use of this oral communications arm is to shackle and enslave one of man's most sensitive faculties.

The alcoholic in his cups often brings disaster and mayhem upon himself by the uninbitied and misuse of this noble tool. Afterwards he cries abuse because of his irresponsible use of this flapping organ.

Out of an average group of a hundred young men 25 years of age able to buy life insurance, 54 will be dead broke, 36 dead, 5 weak, 4 in comfortable circumstances, and one rich, when they would have reached the age of 65.

These strange facts arise from the balancing up of their accounts in the ledgers of life. Every life has its debits and its credits. Our debits are duties, obligations and responsibilities. Our credits are rights, privileges and prerogatives. Fulfillment of the debits procures and secures the credits.

A "duty" is that which a person is morally obliged to do, or refrain from doing. An "obligation" is any duty imposed by law, promise, contract, social requirement or kindmess. A "responsibility" is that for which one is held accountable. A "right" is a power to which one has a just or lawful claim. A "privilege" is a right or immunity granted as a peculiar advantage or favor. A "prerogative" is a prior or exclusive right or privilege, especially as attached to office or rank.

Any building or structure, in order to endure, must rest upon a foundation fixed upon bed rock. Any life, in order to endure, must rest upon the foundation of "confidence". This, in turn, rests upon the bed rock of "satisfaction", which must be deeply imbedded in the earth of "sober service". Service, in the sense of usefulness to ourselves and fellow AA members, is the secret of sobriety; which is the progressive living and realization of a worthy ideal by the demonstrated application of the Twelve Principles.

The requirement for membership in AA can be easily filled by use of the tongue. Fulfillment of the requirement does not fulfill the debts nor secure the credits of our fellowship. These must be earned through sobriety and service.

And so it is with the tongue.

Because, what you are speaks so loudly that I can't hear what you say.

Seminar On Alcoholism

From January 29 through March 11 at 7:30 to 9:30 pm on Thursday nights, a mini-course is being given at Ohlone College in Fremont on "About Alcoholism". The course is sponsored by Ohlone College and the National Council on Alcoholism. Class topics include "Alcohol and the Economy", "Alcohol and Medicine", "Alcohol and Women", "Alcohol and Youth" and "Alcohol and the Family". Panelists include medical, clergy, professionals in alcoholism and drug abuse and an Alateen plus two "teen-members" of Alcoholics Anonymous. The moderator is Dick Denny, Community Coordinator, National Council on Alcoholism.

AA Displays at County Fairs

Win S. of Salano County recently shared his experience with setting up an AA display at the Salano County Fair in 1975. He said that more AA literature was picked up by visitors at the AA booth when it was unmanned, probably because visitors felt less inhibited. He said that if your District is planning to have a County Fair Display, then your P.I. chairman should contact the Fair Board Chairman of your county because "all county fairs have available free space for public service displays."

"School" for Speaking at Non-AA Meetings

A public information work shop was held on "Speaking At Non-AA Meetings" on Saturday, February 7th in the Southgate Community Library Building in Sacramento. The meeting was in two parts: (1) discussion of the relationship of AA to the community and (2) detailed experiences of relationships to professionals. The purpose was to learn the do's and don'ts of speaking before non-AA groups. The question and answer period was handled by AA members who have talked before many non-AA groups. A tape of a talk given before a high school group was used as a model training device. The sample talk was very effective in showing the "do's" of this type of AA speaking.

Almost a hundred people came, from as far as Redding, Chico and Red Bluff. Such interest shows the importance which is beginning to be attached to this subject in the Northern Interior Area. Plans are to continue these meetings on a monthly basis. Next meeting is scheduled for March 6 at the same place with morning and afternoon sessions, as before.

Books in Santa Clara Libraries

It took about four months, but it was worth it! The Public Information Committee for the Santa Clara Intergroup just completed a four-month project. Copies of Alcoholic Anonymous and the Twelve-By-Twelve are in each public library in Santa Clara County. It took cooperation of the South Bay Library Association. All copies were donated by individual AA groups. Congratulations to George M. and the P.I. Committee.

Unity Day Success!

San Francisco's Unity Day was celebrated on January 17th at St. Mary's Cathedral. The Unity Day was sponsored by District 600 of General Service, who gratefully acknowledges the full cooperation and participation of the Central Services Committee, the H & I Committee, Young People in AA, the P.I Committee, AlAnon Intergroup and Alateen.

The program opened with workshops on "How Best to Help the Beginner" and "Cooperation and Affiliation". Workshops were followed by a B.Y.O.B (brown bag) lunch and an informal discussion period. More than one hundred people participated in the workshops. Over 250 heard Arnold R.'s beautiful sharing at the afternoon open-speaker meeting. The program was considered a success by all.

The unexpected attendance at the workshops and the vigor of the discussions suggest that the topics are close to the hearts of those in the AA way-of-life in San Francisco. These topics were selected as the result of early liaison among the cooperating groups and committees. The inclusion of AlAnon and Alateen on the same program was a departure from the usual Unity Day procedures, where AlAnon and Alateen meetings were separate and concurrent. Several observers remarked on the smooth and comfortable way in which members of the three groups could discuss topics pertinent to the three organizations.

Play Review

Those of us who attended the Valley Service Center's fifth anniversary celebration in Pleasanton were given a very special treat. On the last Saturday in January, a group of recovering alcoholics presented the TWELVE STEPS PLAY, by Homer D. of San Leandro. Homer directed the play and also contributed in the role of one of the more religious early AA members..."Praise the Lord!"

The audience of about 150 learned how the beginning AA members helped Bill W. write the Twelve Steps of AA. Homer's detailed study of the characters made the dialogue quite realistic. Bill W.'s review of the play (several years ago) makes it very authentic and probably as close as we can ever get to those circumstances which lead to our Steps. Much heated and serious debate and much love went into the concept of "God as you understand Him". This anvil-like process is exactly what put the temper and the edge into the Steps. A standing ovation testified to the electric effect of the presentation.

What a teaching tool for recovering alcoholics! First, because they can participate in the activities of putting on a play...learning the lines and hearing the steps; but more importantly, because they are exposed to the real debates required to find the best works for out beautiful and healing Steps. Thank you, Homer D.!

The first time I saw Homer's play (about two and one half years ago), I wanted to send it back to my Sponsor in Texas, hoping that the play could be used there to help teach AA's message of recovery through Action, Unity and Service. Maybe this will still happen...
