- NCCAA Spring Conference in San Jose, March 15-17, 2024 – Great turnout. Reg was 690 (that is really good!). Included 60+ Sponsored reg many used by local Recovery places, lots of early recovery AA's who did service. A big win-win. Other conference highlights included:
  - Great speakers, H&I Panel excellent topics, Traditions Workshop with scenarios, Miguel H. Alt Delegate spoke and had time for questions.
  - Election for Chairperson was held. Big TY to Claudio, Alt-Delegate Area 07 for assist on election. Mary M was elected for 2nd two year term (that the limit, 2 x 2 year terms). *Reminder on NCCAA Structure, there are 2 elected positions, Chairperson and Treasurer (nominated through the Steering Committee and Elected at the Spring Conference)*
- 75th Fall Conference is in Sacramento, October 4-6, 2024. Reg is live on website, norcalaa.org. Great Speaker lineup. There will be a Concepts Presentation Saturday afternoon. Conf less than 4 months out – let's get the word out for Registration & hotel reservation. Host Committee going well – strong Chair, Al V. & Co-Chair, Sue B.
- We have an ASL Contact. Monique C. She has an ASL Business and was able to provide ASL in San Jose for the Friday and Saturday night meetings. This has recently been a gap for NCCAA, so we are happy to be back on track.

- **Upcoming Modesto, March 7-9, 2025.** Christina, Helen, Jason and I met with Marisol, DoubleTree Hilton. We reviewed venue space needed, contract and quick walk through. Expect contract to be signed by mid-July. Speaker slate is listed below. Registration for Modesto will open at the Sacramento Conf.
