# Cliff J. Takes G.S. Post In Lively Voting

After balloting seven times, Cliff J., Group Three, Sacramento, won a hotly contested campaign for Chairman-Delegate of Interior Panel Two General Services. It is for a two-year term.

At D., Midtown Group, Stockton, runnerup, was elected by acclamation to the post of Secretary-Alternate Delegate. Harold M., East Yolo Group, Broderick, was named Treasuerer on the first ballot.

Out of 100 possible voting units 46 groups were represented in the balloting, a record-high representation in Panel Two meetings.

The General Service meeting held Saturday afternoon, January 13, in the Labor Center, Sacramento, was also highlighted by the reorganization and redistricting of Panel Two for a more equitable distribution of committee representation. This chore was accomplished and formally became effective January 13. (For a revision of Districts, see Good News, Page Four, issue of January 1962.)

The event was organized by Chairman J. M., Sacramento, and aided and abetted by General Service members from many parts of Northern California. The election was presided over by Jim, supported by a panel composed of Floyd B., Rosedale; Lloyd S., Panel One Delegate, Santa Clara; Duane R., Modesto; Jules P., L.A. Delegate to the General Service board; Stan W., Fairfax and Rollin W., Good News representative, San Francisco.

Two areas, Redding and Chico, were complimented for sending a delegation from long distances, and Stan W., Bill G., and Jim A., all of San Francisco Inter-County Fellowship served as tellers in the vote tallying.

#### Jules P. Talk

Some 450 persons crowded the Labor Center hall in the evening to hear Jules P., the bilingual Chairman-Delegate from Los Angeles give a dramatic AA pitch. Jules chose the Sacramento meeting rather than accept an out-of-state AA gathering to which he also had been invited. He was given a standing ovation by the hall-packed audience.

# **Listing Policy Under Debate** At N.Y. Meet

Up for discussion at the General Service Conference, set for April 25-29, at New York City's Hotel Roosevelt, will be the question whether current listing policy incorporated in the printing of AA World Directory gives a distorted picture of AA in some localities, largely due to duplication. To clarify and probably obtain a truer image of AA in the United States, four separate questions will be considered.

A. Should G.S.O. continue to carry the membership census of .. a group in the World Directory when it is known that such membership duplicates membership of other groups?

#### BACKGROUND

Duplication lowers contributionper-capita in the area. Breakfast Groups, Women's Groups, Court Groups etc. are typical of those that might report membership duplications. (We already follow this procedure for Central Offices and Clubs.)

B. Should groups that have been formed to provide sponsorship for transient alcoholics be moved from listing with regular groups and shown in the Directory under the heading: Special Meetings?

#### BACKGROUND

Groups formed to sponsor alcoholics under court jurisdiction in Salvation Army facilities, Municipal shelters, etc., have, if they wished. been listed as regular groups in the World Directory. It has been reported to G.S.O. that some A.A.s feel that these groups are not regular groups, but are special meetings for sponsorship.

C. Should G.S.O. Staff continue to be guided by the general policy that appears on the front of the World Directory?

Traditionally, any two or more alcoholics meeting together for purposes of sobriety may consider themselves an A.A. group, provided that, as a group, they are self-

#### BACKGROUND

G.S.O. Staff has received requests from General Service Conference Area Committees and other service committees to eliminate listings of groups already registered with G.S.O. Objections were on grounds that listing either lowered percapita contributions from the area. or did not present a true picture of A.A. activity in the locality. G.S.O. has been guided by the principle of "group autonomy" as expressd in the statement on the Directory cover and has replied that they can make the change only if the group agrees to it.

Should General Service Conference Delegates and Chairmen of Area Committees be listed in the World Directory?

#### BACKGROUND

This information is not readily available to groups in any of G.S.O.'s literature. It could serve to improve communication throughout the movement.
