# NCC CONFERENCE SET HUNDREDS TO ATTEND

Some 1200 AA members, their families, and friends, will discover, or re-discover Eureka, the capital of the Lumber Empire of Northern California, when they gather there Saturday and Sunday, June 1-2, for the mid-Summer NCC Conference of AA, hosted jointly by the Humbolt and Del Norte Counties of Alcoholics Anonymous.

# 5-Day School On Alcoholism

The California School on Alcoholism, a five-day seminar, will be held on the Berkeley campus of the University of California, June 17-21, under the joint sponsorship of the School of Public Health; and University Extension, University of California, Berkeley; and with the Division of Alcoholic Rehabilitation, State Department of Public Health.

It is expected to be of prime interest to public heatlh officers, medical personnel, social and welfare workers, educators, nurses, enforcement and correctional officers, judges, lawyers, clergymen, and personnel officers.

Correctional, legal, medical, socialogical, psychological, educational, and personnel aspects of the problem will be covered under the following broad headings:

Metabolism of Alcohol, Biological Effects of Alcohol, Diagnosis of Alcoholism, Incidence and Distribution of Alcoholism, Causation of Alcoholism, Official Agencies and Alcoholism, Drinking and Driving, Non-Official Agencies and Alcoholism, Treatment of Alcoholism, and Current Research in Alcoholism.

### ROOSEVELT ASKS GROUP AID TO OFFSET 1963 DEFICIT

Archibald B. Roosevelt, national treasurer of Alcoholics Anonymous, appealed to the more than 10,000 AA groups in the U.S., Canada, and overseas, to help defray an expected operating deficit in 1963.

The sole surviving son of the late President of the United States Theodore Roosevelt, and a non-alcoholic director of AA's General Service Board, Mr. Roosevelt pointed out some financial hurdles that may be easily overcome by group effort. Said he:

As this letter is written, the number of A.A. Groups-in the U.S. and Canada, in prisons and hospitals, in foreign countries - has passed the 10,000 mark. This tells us that our beloved recovery program will be available to still more thousands of alcoholics in the years ahead.

AA growth increases the demand for General Services. This year more than 1,000 new Groups will need help-free starting literature, much shared experience through letters. Foreign Groups will need pamphlets priced in line with their low economies. Mailing and Board meeting costs will go up to keep pace with a growing A.A.

A.A. growth make the problem of self-support of G.S.O. one that we must all face. New Groups are less able to carry their share-A.A. must count on older Groups to pitch in beyond their share. Here is a brief budget picture for 1963:

1. General Services, carried on at the 1962 rate, will cost .....\$303,000

2. Contributions, estimated at the 1962 rate, will total .....\$274,000

That leaves a minus of....\$ 29,000 If the sale of boks and pamphlets continues to increase, some publishing income can be used to offset the red figures (before the balance goes into the Reserve that has been set up to guard A.A.'s future).

Groups can prevent this service deficit by doing something about Spring contributions. The yardstick most frequently used is a Group share based on \$3.00 per member annually-usually taken from the Group treasury and often added to through the contributions of mem-

## **Rutgers Sets** 4-Week Study on Alcoholism

NEW BRUNSWICK—Applications are now being accepted here for the 21st annual session of the Summer School of Alcohol Studies.

The summer school, a unit of the Rutgers Center of Alcohol Studies, is a four-week-long program dealing with problems relating to the use of alcohol. It is designed primarily for educators, clergymen, physicians, social workers, nurses, correctional officers and others engaged in the rehabilitation of alcoholics.

The school has four main objectives:

1. To examine within the context of the biological, psychological and social sciences, historical and contemporary functions served by the use and non-use of alcoholic beverages in Western cultures.

2. To identify and assess individual and group attitudes toward social drinking.

3. To analyze the impact of excessive drinking and alcoholism on the individual and on social institutions, and to evaluate the community responses elicited by this impact.

4. To provide opportunity for professionals and others responsible for control and alleviation of problems associated with alcohol to expand their perceptions and techniques through lectures, seminars, demonstrations and library resources.

Fee for the four-week residential session, which will be held during July, is \$300. Candidates for admission are advised to write before April 1 to Summer School of Alcohol Studies, Rutgers, The State University, 35 College Ave., New Brunswick, N. J.

It is hoped that each Group will consider this proposal, either approving it, or making suitable recommendations at the Eureka Conference. We wish possible.

During the past year, procedure of the NCC has been restricted by a motion passed in San Francisco. It was the opinion of this meeting that we should not be restricted or limited in any way by the action—or lack of action—by any other segment of AA.

Therefore, it was moved and passed that NCC should be free to follow any plan that would promote the welfare of AA in Northern California as long as such plans do not violate our traditions.

The Secretary suggested that NCC consider the idea of two assistant secretaries. One from the Coastal Region and one from the Valley Region. He feels that a closer relationship between the Groups and NCC will result from a more intimate contact in the two regions. This procedure will also provide a nearby consultant for local Conference Committees. Response seemed favorable to the proposal and it was suggested that definite action be taken upon it at the Eureka Conference.

The meeting accepted the invitation offered by the Santa Clara County Groups to hold our Summer Meeting at the Alano Club, 1122 Fair Avenue, San Jose, on Sunday, July 7, at 1:00 p.m.

### Area 7 "Reps" Gently Chide New York GSO

In their best-attended and liveliest meeting so far, district and group representatives of Area 7 decided April 13 topics to be discussed at the General Service Conference in New York should be relayed to groups for discussion earlier.

About 25 representatives from Marin, Sonoma and Mendocino Counties attended the meeting at the Alano Club, 70 South E Street, Santa Rosa.

To a question as to whether topics to be discussed in New York are prepared early enough for discussion by local groups, those at the meeting replied, "No."

The question was one of several put by Paula B. of Santa Rosa, outgoing area chairman. The meeting was conducted by George B. of Corte Madera, incoming chairman.

The meeting was started with showing of a set of colored slides, accompanied by a recorded explanation, describing the General Service Office in New York and its functions in relation to the AA movement worldwide.

Someone asked whether "Twelve Steps and Twelve Traditions" should be printed in a paperback pocketsize edition. Representatives replied, "No," they thought this would "cheapen the book."

They thus took the same stand as has been taken by other AA sessions, which have decided against a pocket-size edition of the AA basic book, "Alcoholics Anonymous."

William G., delegate from coastal panel No. 1 to the General Service Conference, attended the area meeting and said he would take the sentiments of the meeting to the confrence in New York in May.

#### A three-minute message

Sometimes, newcomers in A.A. will ask: WHO RUNS A.A.? We are perfectly safe in answering: NO ONE REALLY. A.A. HAS NO "GOVERNMENT" AS SUCH.

But the nearest thing to a boss in A.A. is the Group itsself. As a Group, we direct our own activities. And because we want to help other Groups—and because we need more services than we can furnish ourselves—we are part of what is known as GENERAL SERVICES.

The General Service Office or G.S.O. is located in New York, but the direction of it starts right here in this Group. Here we select a G.S.R.—a General Service Representative—who meets with other C.S.R.'s to set up an Area Committee. The committee elects a General Service DELEGATE.

In April, our Delegate will meet with eighty others from the U.S. and Canada to help the Trustees map out their programs for carrying the message worldwide.

General Services is 12th Step work, but on a national and international basis. It helps get Groups started in the U.S. and Canada and all over the world. It helps Groups and Central Offices with their problems of finance, meeting programs, public information and steering committees. It is responsible for publishing and distributing all the books and pamphlets which the Conference approves. It works in a score of ways to help knock out road blocks to A.A.'s growth and progress.

General Services is OUR service office for carrying the message to places, and under conditions, that are beyond the limits of any one Group or Central Office. And just as the direction of General Services starts here in this Group, so does its support. Groups support their General Service Office—their G.S.O.—as they do everything in A.A.—without help from outside the Fellowship.

They do it by sharing G.S.O. costs with twice-a-year contributions—usually figured at the rate of \$3.00 per member per year. Many Groups contribute more—to balance theos who can't carry their share because they are just starting—or because they are in prisons and hospitals, or in low economy countries overseas.

So next time someone asks: WHO RUNS A.A.?

Tell them: NO ONE. WE RUN OURSELVES AND SUPPORT OUR OWN SERVICES.
