Our founding fathers in setting down the program, did not say, "the Steps we read" or "the Steps we memorized" or "the Steps we discussed", or "the Steps we interpreted" but, "these are the Steps WE TOOK which lead us to sobriety and happiness:"

Perhaps the most pointed message Chuck left was not spoken. It struck the minds of many in attendance that here was a man, who after 17 years on the program, still finds it necessary to remain active and share his experience.

To be at the Monterey Inter-Group Meeting on Saturday night, Chuck flew in from Los Angeles. Immediately the meeting closed, he flew back to Los Angeles to be on hand for another session taking place at 11:00 a.m. Sunday.

Ref: Mr. Robert B. Flippin, deceased

On Saturday, August 31, 1963, this institution, myself, and many many other people in California, Hawaii, and all over the U.S.A. lost a dear friend and a great man. This may be unusual procedure for an inmate to feel this way towards a state employee but he was not just an employee to many many inmates. I knew Mr. Flippin since 1948 and he tried to help me many many times. This term he did more than help me, he has shown me a way of life each 24 hours through and with Alcoholics Anonymous. You see, Sir, he is in reality my first AA sponsor and friend.

I had the privilege of seeing him personally on his last day at S. Q. in June when he interviewed me for my July board. He also autographed my Alcoholics Anonymous book and I am proud to say he wrote as follows, "Best Wishes to my AA friend". I know that he has personally saved many others like myself, who by all appearances and according to records were considered hopeless. I hope you knew Mr. Flippin too and understand he can never be replaced."

THE "MYSTERY" OF H & I

Talking to an AA member the other evening after the group meeting, the subject got around to "How does one become active in H&I work?" It seems this member had put his name on an H & I volunteer list, but no one had ever invited him to an H & I meeting. Being a typical sensitive alcoholic, he decided H & I was a closed corporation, and if the right people weren't known, you just didn't participate in H & I work.

Since becoming General Chairman, Bud (former General Chairman) and Harriett (Co-Chairman for Hospitals), tells me this is the phantom story of H & I Work.

Another question often asked by a newcomer—and some of the older members, too: What does H & I stand for and what is its purpose?

JAILBIRDS KNOW

In the beginning, I didn't give these two questions much thought, because, as in the case of many members with longevity on the Program, we think everyone knows what the Hospital and Institution function is all about, not realizing that a great majority of the members of our Fellowship have never been hospitalized or jailed for alcoholism.

An AA member's primary purpose is to "carry the message" and being willing to go to any length in this endeavor. We in H & I work carry the message, too. Some fifty hospitals and institutions from Fresno, north to Eureka are serviced at least once a week.

USELESS LIP SERVICE

Looking at the overall picture of the efforts of the Contact Chairmen of the many hospitals and institutions, whose duties include inviting at least three speakers for each meeting, reminds me of the telephone answering service in our local area. A 12th Step Call comes in and the person has to call everyone in town and practically beg a member to make the call. Then at a meeting you hear someone say, "I signed up for 12th-Step Work, but no one ever calls me.

So through this column in the GOOD NEWS, the Hospital and Institution Committee is making an effort to call you to become active in H&I work. Your assistance is needed. If you knock at our door, be assured that you will be warmly greeted. There is room for evryone.
