Conference Plans Completed

The conference committee handling arrangements for the 17th Annual Conference of the Northern California Council of AA, announced yesterday that it had completed plans for the big two-day convention taking place in Stockton, Saturday and Sunday, March 21-22.

Stan W., secretary, Northern California Council, said his committee had completed plans for the various workshops, business sessions, committee meetings, hospital and institutions, Alanon and Alateen gatherings that would take place in Stockton's Civic Auditorium.

The only affair that will not be held at the Civic Auditorium is the Conference Dinner, scheduled for 6:00 p.m. at the Scottish Rite Temple, West Alpine Avenue.

TEMPTING MENU

The secretary said that a brisk demand for Conference Dinner reservations indicated that a full house of 600 persons is expected. Cost of the dinner is \$4.50, including tax and tip. The menu is generous and tempting and includes:

Bill Bell Dies

One of the first Negroes to obtain and maintain sobriety through San Francisco Fellowship passed away February 24 at a local hospital.

He was William Bell, remembered by many oldtimers that met at St. Cyprian's Church, where the old Inter-racial Group was established.

Bill Bell came into AA in 1947 and played an important part in helping establish the Fellowship Center on Divisadero Street.

One of AA's most active members, he was never known to refuse a 12 step call, day or night, and many persons are sober today because of his tireless efforts, his kindness, and his patience.

It was his opinion that there was no such thing as a "hopeless alcoholic." In recent years, he was physically unable to participate in AA activities, but it did not bar him from using the phone to talk to so — or to listen to someone in great need.

He is survived by his widow, also well-known in AA circles. She resides at 441 Ralston Avenue, San Francisco.

Monthly Sharing Plan Takes "Pain" Out of Giving to GSO

Backbone of Alcoholics Anonymous is the group and its members.

However, any member who has been around for any time at all, knows that the heartbeat, nerve-center, core and fiber — the motor that makes AA go, here in the U.S. and overseas — is the General Service Office, N.Y. City.

The motor is often starved for oil. To keep it from overheating and finally stalling it needs steady, constant lubrication. In this case "lubrication" means funds, money.

OUT OF GAS

Members of AA are, by nature, generous to a fault. Tell them that something worthwhile is in need of support, and they dig deep. Tell them for instance, that the "AA motor in New York is faltering because its out of gas" and they'll blindly donate.

Most of them do not know what GSO is; what the General Service Office does; how it functions; the world-wide services it performs. Actually, many do not know it exists.

This is a fault that is rapidly being remedied largely by General Service Committees that were created under the auspices of the Northern California Council of AA and similar committees established in southern California, and elsewhere throughout the U.S.

TEST AREAS

Let's return to "lubrication."

A really "painless" method of oiling the engine, and keeping it smoothly operating, is the Monthly Sharing Plan. Along with Georgia, Southeast Michigan, and Oklahoma, Coastal and Interior Panels One and Two in Northern California have been selected as "test areas" to try out the Monthly Sharing Plan. If successful, the plan in all probability will be adopted throughout AA.

What is the Plan?

It is nothing new except in procedural contribution to the General Service Office. Heretofore, groups send an Annual contribution, usually sent at Christmas, amounts to \$.00 per member, i.e. if a group has 20 "registered" members, it sends GSO \$60.00. It must be emphasized, however, that only 60% contribute to GSO.

WHY CHANGE?

According to H. K. "Rick" S., chairman-delegate, Panel Two, here's the situation:

The first thought that will probably come to most members is "Why the change from our present system?" We quote from the report of the Finance Committee of the General Service Board, held in New York, November 1-2, 1963:

"For the first nine months of the year contributions from groups to GSO arrive very slowly, then jump way up during the last three months, with December the largest month by far.

"For this reason we are compelled to borrow from the publishing operations (Big Book, AA Comes of Age, pamphlets, etc.) to meet budgeted expenses for a good part of the calendar year. A "Monthly Sharing Plan" would in time result in a larger percentage of contributing groups.

ROOSEVELT'S IDEA

"Another point in favor of a Monthly Sharing Plan is, that in time, we could eliminate our "appeal letters." We have reason to feel that they are not popular in the groups and places GSO in an unfavorable light. Groups prefer, we believe, to make their GSO "self-supporting."

Archie Roosevelt, treasurer, General Service Board, points out: "The time has come for AA, as such, to assume the status of an adult society, and make an attempt to run its financial affairs on the basis of an adult business, realizing that AA will, of course, never be a business as such.

The soft approach to our obligations has reached its peak, and it is expected that we finally face the fact that our World Services needs are approaching the size that almost demands a more realistic approach to financial support."

Rick goes on to explain:

Most of the responsibility of putting this plan into operation has been delegated to the General Service Committees of Panels One and Two, its committee members, General Service representatives, and group secretaries. The following suggestions are offered, but their ap-

plication is a matter of local autonomy.

The approach we all could use is that the Monthly Sharing WILL NOT ask for more money, but only a change in the method of getting it in. We simply send in each month one-twelfth of the amount normally sent during a year.

Suggester per capita figure is twenty five (25c) cents per member per month. This DOES NOT change the present basis of \$3.00 per year, per member.

We (chairman-delegates of Panel One and Two) are requested to put this plan into effect at once and make the following changes in present procedures.

METHOD OUTLINED

1) The monthly contribution will be sent direct to N.Y. but no receipt or acknowledgment will be sent to groups as it is now done. The N.Y. office will enter the donation received in their records. At the end of a three or four month period, New York will compile a list of all groups in Panel One and Two, listing the groups and their individual contributions per month. This list, and all receipts and acknowledgments will not be sent to groups. Instead, it goes to the Panel Committees who will pass on the information through District Committee Members and General Service representatives to the individual groups.

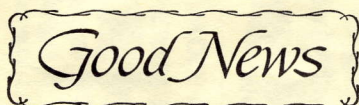
MEMBERSHIP CENSUS

2) The Group Secretary (or Group GS representative) is requested to send as soon as possible, an estimated number of members in their group. This data should be mailed to Box 42 Central Valley, Calif. (This is "Rick's" home address) and this information will be then sent immediately to the General Service Office in New York City.

One other good suggestion: "Regarding GSO contributions as a regular monthly bill, the same as rent, lights, or telephone bill, to be sent in on the first of the month by the group treasurer or secretary.
