"THEME: "PRACTICING THESE PRINCIPLES"

AA RESPONSIBILITIES STUDIED BY 14th ANNUAL GSO MEETING

The General Service Office of Alcoholics Anonymous held its 14th Annual Conference, Tuesday, April 21, through part of Sunday, April 26, at the Roosevelt Hotel, New York City. The first 6-day meeting of its kind attracted more than 120 Area Delegates, Trustees, Overseas Observers, and General Service Office staff members.

They shared their "experience, hope, and strength" to assure the survival of AAs Third Legacy of Service to each other—and to those who may seek help in future days. Among other "Advisory Actions," the Conference:

GENERAL SERVICE OFFICE

- Approved a new film strip describing world services made available through GSO.
- Approved a plan to send GSP correspondence exclusively to General Service Representatives in certain Areas where this distribution method will be tested.
- Approved preliminary results of the Monthly Sharing Plan (regular monthly contributions) in Areas where the plan is now being tested.
- Recorded complete confidence in the operations of GSO and approval of present patterns of compensation for staff members.
- Recommended that the General Service Board consider a pension plan for GSO.
- Recommended that the present pattern of book discounts (whereby the groups have waived a portion of their discount to permit creation of an adequate Reserve Fund) to be continued until next year.

PUBLIC INFORMATION

- 1. Approved a formal statement defining AA's position in the field of alcoholism.
- Urged Delegates and Committee Members to establish communications with other agencies who share AA's concern in this field.

TRUSTEES

1. Deferred decision on a proposal that non-alcoholic Trustees of

- the General Service Board be "rotated".
- Approved the nomination of Bruce M., Ohio, to fill the vacancy created by the death of Class B (Regional) Trustee Howard B,
- Approved the nomination of Murray W., as a Class B (General Service) Trustee.

ADMISSIONS

- Recommended that a second Delegate be admitted from the Atlantic Provinces of Canada.
- Tabled, for future consideration, requests from the state of Indiana and the Province of Ontario for additional Delegates.

CONFERENCE

Recommended that the 1965 Conference cover a six-day period.

TORONTO

Approved operating plans procedures for the 30th Anniversary International Convention in Toronto July 2, 3, 4, 1965 and expressed confidence that it will be well supported.

INTERNATIONAL

Approved a recommendation of the International Committee of the GSB that an experimental "workshop" on AA structure and services be conducted at GSO for locally selected representatives of AA in Latin America.

GRAPEVINE

- Approved making the Conference Committee on The Grapevine "an active part of the Grapevine effort."
- 2. Approved further study of a

- proposed French language "Grapevine".
- Approved appropriate steps to protect the "Grapevine's" interests in copyright material, short of engagement in public controversy.

LITERATURE

- Approved special identifying phrases for Conference-approved AA literature and reprints of other material distributed with Conference approval.
- Recommended preparation of a special "small format" edition of "The Twelve Steps' and "The Twelve Traditions".
- Recommended further study of a proposal to prepare "study guides" to AA literature.

BILL

Reviewed and approved an agreement between Bill W., co-founder, and AA World Services, Inc., covering royalties derived from Bill's writings. (Intent of the agreement is to protect Bill, his wife, Lois, and their designated heirs, while defining A.A.W.S's position as the Society's publishing agency).

PROXIES

Agreed that, in general, it was not advisable to accept proxies fro mregular groups at AA Assembly meetings.

DELEGATES ONLY

As is traditional at Conferences, one evening session was devoted to a meeting exclusively for Area Delegates. All other Conference members were excluded. Claude M., Alaska Delegate, was chairman of the 1964 meeting.

APRIL 30 - A DAY TO REMEMBER

At approximately 7:45 p.m., April 30, the AA clan gathered within the walls of San Quentin prison to pay homage to one of our greatest friends, Robert Browning Flippin.

This was the formal dedication of "THE ROBERT B. FLIPPIN MEMORIAL GROUP" at San Quentin prison.

It was a most solemn occasion, and yet there was a feeling that "Bob" was there with us. Perhaps we can attribute this feeling in part, to the fact that for the first time in many years we were privileged to see a lady on stage. Yes, Kay Flippin. Kay describes herself as a potential alcoholic. Remember the opening remarks of Bob?

IN and OUTER

The official family represented included the former warden, Fred Dickson, the present warden, Lawrence E. Wilson, and the two inside AA sponsors, Ken B. and Neil Z. From the outside, members of the Hospital and Institutions Committee from all over northern California and many other AA friends came to be a part of the dedication ceremonies.

Without exception, everyone called to the microphone voiced the universal respect and affection for Bob. It was stipulated that applause was not in order, however; this admonition was not necessary.

REAL SOLDIER

There was some question in the minds of many as to how Kay would bear up, but she is really a good soldier. The chairman, Harry A., invited Kay to say a few words to the gathering and, believe us, it was her meeting. All rules went down the drain and there was a spontaneous standing ovation coupled with applause like a great roll of thunder A just tribute to a great lady.

We have always known that there is great talent inside the walls and on this occasion the fellows really extended themselves. A huge plaque commemorating the occasion was unveiled. We have no idea as to how much time and effort it took to produce such a piece of work, but it was, and is, beautiful. A smaller replica along with a beautiful portrait of Bob was presented to Kay at the conclusion.




