This is the same day that General Service Committee, Panel 2, is holding their Assembly meeting. That will enable you to attend the NCC Fact-Finding meeting in the morning and the program planned by Panel 2 the balance of the day.

The second meeting will be held at 10 A.M. on November 28th at the Veterans Memorial Auditorium, Grand Avenue and Harrison Street, Oakland. This is the same day that the General Service Committee, Panel 1, is to hold their Assembly Meeting and Election. This NCC meeting will be completed by noon and it will leave you the balance of the day to enjoy the program arranged by Panel 1.

Attendance at the Conferences appears to be falling off, and these meetings are to discuss ways and means of increasing Conference attendance and to stimulate increased activity in the affairs of the Council.

**1,000 ATTEND BANQUET AT SHERATON PALACE**

About 1,000 persons, AA members, their wives and sweethearts gathered in the Garden Court of the Sheraton-Palace Hotel in San Francisco Saturday night, October 24, for a dinner and dance, to celebrate the 29th Anniversary of the founding of Alcoholics Anonymous, and the 26th year of AA in San Francisco.

The diners received a Welcome from the city of San Francisco via its Chief Administrative Officer Thomas J. Mellon, who spoke in place of Mayor Thomas F. Shelley, confined to his home with a virus cold.

Mellon said, "Before I was in government I was in private industry and I know the cost of the ravages of alcoholism in industry. Mayor Shelley told me not only to welcome you but congratulate you for your excellent work. He is very impressed with your record—and so am I. I know what AA has done for the Police Department".

Eneas K., Master of Ceremonies, pointed out that guests appeared from as far as La Jolla, Calif. and Medford, Ore. After introductory remarks by the chairman and Mellon, actor John A. spoke in substitute for actor Ed B., who wrote that he had been restricted to a regimen of diet and rest by his doctor.

The featured speaker, a member of the Beverly Hills group told a story of repeated arrests for drunken driving and other escapades which he termed "a life of insanity".

"I believe I was born an alcoholic", said the speaker, tracing the story of his life of drinking that began when he was a student.

In one instance, he related, he had not had time to undergo trial for one drunken driving charge when he again was arrested for the same offense.

After a number of tries at getting sober he had a letter from a friend, a member of AA, "at a time when I couldn't get drunk and I couldn't get sober".

The friend asked whether the actor had "had enough". He had.. Since then he has been attending AA

meetings nearly every night of the week. "And I now have been sober for 15 months, a relatively short time compared to my life of insanity in drinking—but a long time sober for me".

Following the dinner and the featured talk, which constituted a "big meeting" of AA, the floor of the famed Garden Court was cleared and the guests danced until 1 a.m. to "Anson Weeks style music", played by the orchestra under the direction of Carlton Ackley.

Besides Chief Administrative Officer Mellon, there were these honored guests at the speakers' table:

Municipal Judge Fitzgerald Ames; Sheriff Matthew Carberry; Martin Covitz, executive-director, San Francisco Council on Alcoholism; Municipal Judge Emmet Daly; Clinton Duffy, former warden of San Quentin Prison; Cliff Engle, chief of the KFRC news department and producer of "The Problem Drinker" radio program; and Dr. Arthur C. Hollister, chief of the Division of Alcoholic Rehabilitation, State Department of Health.

Invocation was by the Rt. Rev. Msgr. Vincent F. McCarthy, representing His Excellency, Archbishop Joseph T. McGucken of the Catholic archdiocese of San Francisco.

Benediction was by the Rev. Canon Robert E. Hoggard, representing Bishop James A. Pike of the Episcopal Diocese of California.

Among messages receiving prolonged applause was a letter from Bill W., the surviving co-founder, who said he and his wife still cherished the time they had visited San Francisco during the early years of AA.

## H&I BROAD-SIDES

Gratitude Month! November, lest we forget. Thinking over the past year, the many things that I remember with a good feeling, especially my sobriety—learning to do all things in moderation and how far I have failed in attaining complete sobriety. The many people on the program who were interested and dedicated to H & I work; who, becoming frustrated for many reasons, returned to their old ways of thinking. These are the people I am concerned about as I write this column and I ask myself "Why?". Then I think of the booklet "Why We Were Chosen" and of the many members of the H. & I. Committee who have over the years found a better way of living and are willing to "carry the message."

For instance "The Four Horsemen" who, over the years, have faithfully attended the regular AA meeting at San Quentin. For years I had heard of the "Four Horsemen" but I never knew who they were or how they came to be known as "Four Horsemen." Then I found out that this group of AA members conducted such a fine AA meeting over the years, they were given the nickname "The Four Horsemen" by the inmate members of the San Quentin Group.

There is rather fine story background to the members of this group. In the past I have asked some of the original members such as Jack I. and Stan W. to write an article about the "Four Horsemen," but neither one has got around to it yet, so perhaps this little reminder might shake one of them up. I think all of us would enjoy reading the history of how to 'carry the message' as practiced by "The Four Horsemen." so successfully. Of course there are many other examples of people who have made the N.C.C. H&I Committee what it is today.

I am reminded of that very fine and devoted servant Rex N., who went to the big meeting in 1957, and his right hand Bill G. who replaced Rex as General Chairman at the N.C.C. Open Alanon meeting of the Avenue Alanon Group on Wednesday, the 18th, 8:30 p.m., according to Murrel S., program chairman.

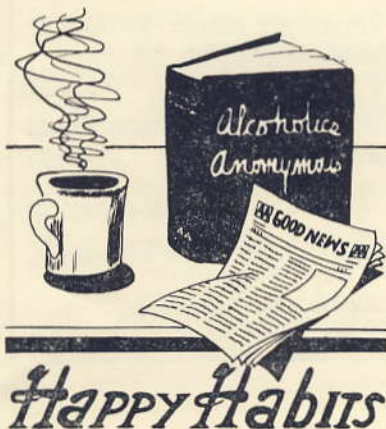
Both Chris and Randy are active in their home groups and, as a team, should provide a most interesting program. This is an OPEN meeting.

# COMMENTS ABOUT AA CRITICS

In view of the fact that the Fellowship of Alcoholics Anonymous has helped more very sick alcoholics to achieve, and maintain, continuous sobriety than all other alcoholic recovery agencies, combined, it is difficult to understand what the critics of AA hope to gain from their efforts to depreciate our fellowship in the eyes of the public image.

Never the less, the articles criticising AA, which appear in nationally known publications are increasing in number and this is a state of affairs which we must learn to face with serenity for it is one of the things we cannot change.

One of AA's critics charges that the "top councils of Alcoholics Anonymous" have lost touch with the rank and file members of AA's 10,000 local groups. To the uninformed public, this may indicate a serious flaw in AA's structure. But to AA's who are familiar with the provisions of our Third Legacy this statement borders on the ridiculous. He also insists that our current AA literature sounds archaic to the young men of today.

### NEVER ARCHAIC

Since I am no longer a young man, I am not in a very strong position to contest this statement. However, it is my belief that literature, which is inspired by that which is right and good, will never sound archaic to those who are dedicated to the right and good. The Torah, the Koran and the New Testament were written centuries ago but they will never sound archaic to the Jew, The Mohammedan, or the Christian. By the same token, the approved literature of AA, regardless of its age, will never sound archaic to those who realise our literature is akin to a jewel case for it contains the golden key to sobriety.

### NOT CULTISTS

Another avowed critic of AA expresses his belief that AA is becoming a religious cult and he makes the amazing statement that the members of AA, utter the word 'SOBRIETY' in 'HUSHED AWE', and I humbly ask the reader's indulgence for injecting a statement, based on my personal experience, to serve as a rebuttal.

Since coming into the fellowship, more than twenty years ago, I have

attended more than 3000 AA meetings, and I have yet to hear one of my fellow members utter the word 'SOBRIETY' or ANY OTHER WORD in 'HUSHED AWE'

The same critic also chides AA for enslaving its members to self-righteous sobriety and I am certain that I am speaking for the overwhelming majority of AA's in saying that the person who can visualise an alcoholic enslaving another alcoholic or forcing that alcoholic to do anything or say anything he does not want to do or say, is merely confessing his crass ignorance of the characteristics of the alcoholic.

### FRUSTRATED MAN

A number of fellow members have expressed their deep concern regarding these articles, but as a matter of fact there is no cause to be alarmed. The above comments of AA's critics result from the deep frustration men experience when they try in vain to produce a comparable substitute for the program of Alcoholics Anonymous..
