COASTAL AREA "LINK"

Here are the main headings of the 1985 Conference agenda topics: Will the Hand of AA Always be There? The Six Warranties. Beyond Tradition Seven, Group Responsibility. Fifty Years of Caring and Sharing. The GSR, The Key Role. (The phrase, agenda topics, is inevitably tied in with such terms as conscience and authority.)

The groups hold ultimate world service authority, but the active, effective conscience of AA as a whole finds its voice in the

General Service Conference. The groups have final authority; their representatives have operational authority. The Conference listens closely to group opinion. Nevertheless, it possesses a discretional Right of Decision. It rightfully decides what it will dispose of itself, and what it will refer to the groups, or, more usually, to the GSR's or DCM's, for opinion or guidance.

Despite its "supremacy", group conscience as a totality is limited. It can't always be fully informed. It may not be the best guide in a grave disturbance. Accordingly, trusted leaders should be ever ready to do for the groups what the latter cannot or should not do, at times disagreeing with uninformed or biased group opinion. Ultimate authority is qualified by delegated authority. Group conscience is the ultimate authority. The trusted servant is the delegated authority. One can not function without the other. The essentials for harmony are careful definitions and mutual respect.

In the spirit of fellowship, the Conference refers the above agenda topics to group conscience for opinion and recommendations.
