

# **Tradition One:** A.A. Unity -- Our Lives Depend On It!

Tradition One states that, "Our common welfare should come first; personal recovery depends upon AA unity." The Long Form notes that "Each member . . . is but a small part of a great whole. AA must . . . live or most of us will surely die. Hence our common welfare comes first."

In <u>Twelve Steps and Twelve Traditions</u> we read the following, *"Few drunks could ever get well on their own steam, but . . . we could do together what we could not do separately."* 

Unless there is approximate conformity to AA's Twelve Tradition, the group... can deteriorate and die."

Since recover from alcoholism is life itself to us, it is imperative that we preserve in full strength our means of survival."

<u>AA Comes of Age</u> declares that, "Most individuals cannot recover unless there is a group . . . No personal sacrifice is too great for (the) preservation of the Fellowship . . . The group must survive or the individual will not . . . In our groups we could do together what we could not do separately."

In <u>As Bill Sees It</u> we are warned that — "Given still more 'righteous' indignation, the group can . . . die."

### News From The Hospitals & Institutions (H&I) Committee

As always and first off, thank you all for your financial contributions to the work of our Committee. It is gratifying to realize that the general membership of Northern California A.A. is aware of the benefit to those confined of the monies placed in the Pink Cans. So a heartfelt *"Thank-you"* from the Committee, its members, and those who receive the literature it buys.

As many of you know, the Hospitals & Institution Committee of Northern California Conference of A.A. is organized under the umbrella of Tradition Nine. We are responsible to those we serve which goes two ways - to the fellowship to carry our message of recovery and to those confined to whom we carry that message of hope and of recovery. We do have regular General Committee Meetings at which <u>anyone</u> who is doing H&I work is welcomed and eligible to take part in the discussion and the voting.

Our next General Committee Meeting will take place in Region 70 (San Jose) on February 16, 1997. Three amendments to the Pink Book (H&I's) "bible" of organization will be discussed and a vote taken. They have all been presented once at the last General Committee Meeting and this will be the final vote. The three are (1) making the Grapevine Distributor a permanent Steering Committee position with a requirement of three years of sobriety for the person taking that position, (2) a provision that members of the H&I Committee, when carrying the message of AA into a facility, refer to themselves only as alcoholics, and (3) provisions outlining more specifically how we are to dress when carrying the message into a facility so that the message not the messenger stands out. So, if you are involved in H&I in Northern California, please be on the lookout for the announcement of the exact location of this meeting in February.

Finally, the "Big Book" says, in Step Twelve, "Having had a spiritual awakening as the result of these steps, we tried to carry this message to alcoholics"... and again, "nothing will so much insure immunity from drinking as intensive work with alcoholics". Those who work in H&I will attest to those statements from the practical experience of carrying the message to another alcoholic and having that act save them from drinking one more time. If nothing else, hearing the stories of those confined may remind you of the grace of God that saved you from such confinement when you did the same things. And, we can say, "there, but for the grace of God, go I". It is a sobering moment for those who experience it. That can be you if you come join us on this road of H&I to happy destiny. Will n. 🙂



### **Preserving Our History**

### Then & Now: 50 Years of Experience

Editor's Note: Continuing our articles from long time AA sharing their experience we include an article written in 1947.

Just after I got a firm grip on sobriety and a sturdy handle on the entire A.A. program (in about three months) I had a shocking and aggravating experience.

I was in attendance at a "speaker meeting" prepared as usual to enjoy the speaker. However, my plans for enjoyment were rudely destroyed. The reason? Wait until you hear. This so-called A.A. speaker, in front of a large audience (for those early days) of perhaps seventy-five made an ego-shattering statement. This is what he said.

#### "ALCOHOLICS ARE EMOTIONALLY IMMATURE"

What a stupid and needless thing to say in front of all those people. That he was emotionally immature was obvious. He also went on insultingly to say that alcoholics were "picked green emotionally". Green indeed ridiculous - positively!!!

Since I was forty plus at the time, it would be clearly impossible for ME to be emotionally immature. I tuned out the rest of this man's blathering and engaged myself in taking his inventory. I was GOOD at this. On the way home from the meeting I continued my inventory taking. Suddenly the thought crossed my mind - "Why am I so upset and resentful?"


The answer sprung at me - full blown. The reason I resented his remarks was because they fit me EXACTLY. It was a revolting but true fact. After mentally walking through a couple of drunks I could remember I convicted myself.

So there I was - a sober, smart-aleck, know-it-all member of A.A. with yet another burden to bear -'emotional immaturity'. However, over the past thirtythree years, I sometimes get the feeling that I am a little LESS immature emotionally - through God's grace and the AA program - SOBER.
