# Remembering Dr. Silkworth –

# "Change! - Everything"

It was the late forties. I was in terrible shape and had been drunk for weeks. I was in a semiblackout, and usually came to in joints with sawdust floors. My father knew a man who had been a notorious drunk and was now clean, and my father asked him to help me. The man, Roy, drove me to New York City, and checked me into Knickerbocker Hospital. The charge was eighty-five dollars, and I didn't have a dime, so Roy footed the bill. I was so sick, they were reluctant to take me in that night, but the next morning they did.

I was first met by a big red-haired lady named Teddy, and boy was she tough. She gave me a little shot glass with a blackish liquid in it, and a pill the size of a golf ball. I didn't know it at the time, but they believed in cleaning out the inner man upon admission. The combination really worked. I wont go into details, but you know what I'm talking about. I was out of commission all day, once the concoction started to work.

I was in a small ward with five or six other drunks. (One of them, I found out a few days later, was a prominent feature writer for one of the large newspapers). Day two was more or less a blank. On day three, I was introduced to the doctor, a very small, fragilelooking old man with white hair, and, I believe, an old sweater. He had an extremely kind face. He told me his name was Dr. Silkworth and that he was familiar

with alcohol-related problems, and proceeded to talk to me. The most unusual part of the meeting was that he did not ask any questions (as most psychiatrists do) but told me the story of my life. It shook me up a little. He told me alcoholics of my kind (daily periodics) were most difficult to help, and that my prognosis was not the best." "But," he said, "there is a chance for you." In my hopeless situation, my ears perked up, and I asked, "What chance? What do I have to do?" He looked at me and said "Change!" I asked, "Change what?" "Everything," he said. He told me that my every thought. every attitude, every reaction had to change. No holding back.

Dr. Silkworth subsequently told me a story I will never forget. He said, "There was a storekeeper in upper New York state who had run a hardware store in the same neighborhood for many years. He knew most of his customers by name and had a thriving business. Now the new strip malls were taking over, and all the merchants on his street were moving. But, being loyal, the hardware man could not bring himself to close his second home, his store. His accountant came in one day, and said, " Al, your business is off by seventy percent. If you don't join the other merchants in the new malls, you will be forced out of business." AI finally agreed to open up a store in a strip mall.

Business flourished, and after about four or five months, the accountant came by with the books and said, " AI, sit down." He said, "I can't understand what's happening here. You're doing well and making money. But it's going out as fast as you're making it. So where is the profit going?" AI grudgingly admitted to the accountant that he had never closed the old store.

This has stayed with me for the half a century I have been sober in Alcoholics Anonymous. It told me that I could not keep doing the things I had done while drinking -I would have to eliminate them and replace them with new friends and new thinking (which I found in AA).

Dr. Silkworth told me that the Twelve Steps of AA would gradually induce the changes he was talking about. It might take time, but it would happen. It has. He also told me I was like a driver going the wrong way on a oneway street. A policeman stops me and points to the hundreds of cars coming toward me. "Can't you see the sign?" he asks. "You're on a one-way street." I look at the sign. look at him. and "Who turned the sign ask. around? I think the good doctor liked his little stories. As the years went by, they made more and more sense.

I went back to the hospital a few times, to sit in "Duffy's Tavern," a little hideaway just for the drunks on the ward. Dr. Silkworth and Teddy were always ready to welcome alcoholics who were trying to recover.

I realized recently that there are very few alkies alive today who were treated by Dr. Silkworth, and that perhaps I should write out a few lines describing my experience with this beautiful, medical saint, who was so instrumental in getting Bill started in this life-saving program of Alcoholics Anonymous.

Bless you, Silky, for your dedication to a segment of society that was really not welcome anywhere. I, for one, am eternally grateful.

# **Our AA Literature**

From time to time, I hear about groups who refuse to put out any literature on their tables or racks at meetings which does not specifically state "Conference Approved Literature" on the front cover. It's great to see such a passion for upholding AA' s singleness of purpose by not having literature from other fellowships mixed with our own, potentially causing confusion in the newcomers. However, some are not aware that there is other AA literature, which is not necessarily "Conference Approved."

Your General Service Office in New York prints a wide variety of "Service Material" which has not about through come а Conference Advisory Action. It is produced when there is a need for readily available information on a specific subject, and reflects collected AA group experience as well as specific and timely information that is subject to change. Some examples of these include: AA Fact Sheet, AA Guidelines, AA Preamble:

Background, Concepts Checklist, Traditions Checklist, How to Conduct a Sharing Session. Sponsorship-Vital Stepping-Stone to Ser- vice and Sobriety, Suggested Topics for Discussion Meetings Suggested and Workshop Format. There is also a Memo to Group Treasurers to help groups understand the scope of their jobs, and ways funds in excess of the group's prudent reserve can be put to good use. One more ser- vice piece is The AA Archives, a valuable piece about how you can get involved in preserving those 'evidences of our history.' Much more is available at www.aa.org or by contacting GSO. GSO also publishes a newsletter

for the Fellowship called *Box* 459. There is a newsletter for professionals called *About AA* .The GSO Archives publishes *Markings-an Archives Interchange*.

Intergroups and Central Offices often publish Service Material to fulfill local needs, whether it is guidelines for the local hotline or meeting directories. Public Information Committees often create Service Material for their local needs as well.

The Northern California Hospitals and Institutions Committee (H&I) publishes auidelines and workbooks to assist members in doing their corrections and institution work better. The Bridging the Gap Committee also publishes information cards, both for people wanting to do 12th Step Work as well as contact cards for those incarcerated due to be released soon and need someone to help them get to their first meeting on the outside.

Everything I've mentioned above *is* considered to be " AA Literature," and all serve a very important role in helping us to fulfill *our primary purpose.* Whether groups choose to put this material on their literature tables is, of course, up to the group's conscience, but I hope you'll look into this rich collection of experience, and share it with your group's members.
