Treasure Elections

Treasurer elections will be held in Foster City. This process begins at the Steering Committee meeting at 8:00 am. Listed below are the Election Procedures and Requirements for the Position if you would like to make yourself available for this position contact one of the Steering Committee Members.

Election Procedures

The Steering Committee of the Council will sit as a Nominating Committee for the purpose of accepting nominations for the election. The roll will be called of all Steering Committee Members who may or may not place a name in nomination. After the roll of the members has been called, the nominations are considered closed. The Nominating Committee will then discuss the qualifications of the nominees and select a slate of nominees, recommended to be at least three (3). Those nominees selected will then be voted on by the Council Steering Committee and Delegates at an election held at the NCCAA Open Delegates' Meeting of this same annual Spring Conference.

Treasure Requirements

The Council Treasurer is elected at the Spring Conference of the ODD numbered years, and serves a two (2) year term. This office is restricted to no more than two (2) consecutive terms.

A Financial Report of each Conference is to be prepared and presented at the Pre/Post Conference meeting following the Conference and at the next Conference Steering Committee meeting.

A Financial Statement as June 30 and December 31 of each year is to be prepared. Each of these financial statements will be reviewed and approved at a meeting of all of the officers of the Northern California Council, as soon as possible after completion, and each is to be published in the next available issue of the Good News.


The books of the Council shall be available to any AA member or group for inspection at any time.

The Treasurer may delegate any, or all, of the above responsibilities to one or any of the Secretaries, or in case of necessity, to any responsible AA member. The Treasurer shall, however, assume full responsibility for any functions so delegated. If the Treasurer is unable to assume the duties of the Council, a temporary Treasurer will be selected by the Chairperson until a special election can be held.
